ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is BAI TRUCKING, INC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office of the corporation is 3499 Woodridge Parkway, Palm Harbor, Florida 34684, and the mailing address of the corporation is 3499 Woodridge Parkway, Palm Harbor, Florida 34684.

ARTICLE III - DURATION

The duration of the corporation is in perpetuity.

ARTICLE IV - PURPOSE

The general purposes for which the corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.

ARTICLE V - CAPITAL STOCK

The maximum number of shares which the corporation is authorized to issue is 1000, par value \$ .01 per share, all of which shall be common shares. All common shares shall be identical with each other in every respect, and the holders of common shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII - THE INITIAL BOARD OF DIRECTORS
