ARTICLES OF INCORPORATION OF MUSIC BUDDIES, INC.

SER 27 RM W. 13 The undersigned, for the purposes of forming a corporation under the Florida general Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE ONE NAME ...

The name of the corporation is Music Buddies, Inc.

ARTICLE TWO **DURATION**

This corporation shall commence existence as of the date of execution of these articles. The term of existence shall be perpetual.

ARTICLE THREE PURPOSE =

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE FOUR CAPITAL STOCK

The price and terms at which, and the time within which such shares may be offered and resold shall be determined by an affirmative vote of 3/4 of the outstanding shares of this corporation.


