ARTICLE I

The name of this corporation is JOSEPH PETERS PAINTING AND WALLCOVERING, INC. The principal office and mailing address of this corporation is as follows : 2640 Pebble Creek Place , Port Charlotte , Florida 33948 .

ARTICLE II

This corporation is organized for the following purposes : To carry on any business , occupation , undertaking or enterprise and to exercise any power or authority which may be done by a private corporation organized and existing under and by virtue of Florida Statutes , Chapter 607 , and it being the intention that this corporation may conduct and transact any business lawfully authorized and not prohibited by Florida Statutes , Chapter 607 .

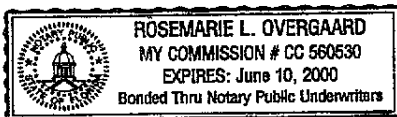

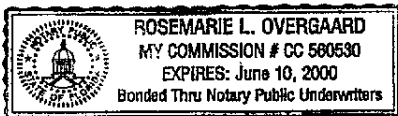
