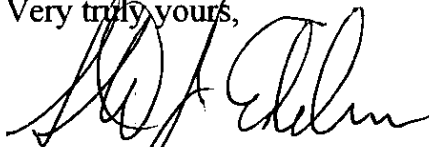
Gentlemen:
