4. The corporation may issue one thousand (1000) shares of stock, all common, with no par value. The initial shareholders of the corporation shall be as follows:

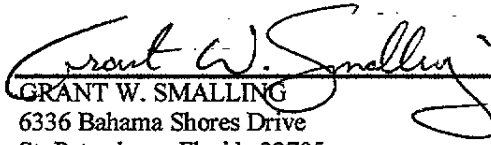
