ARTICLE I - NAME

The name of this Corporation is BDR Telecom, Inc.

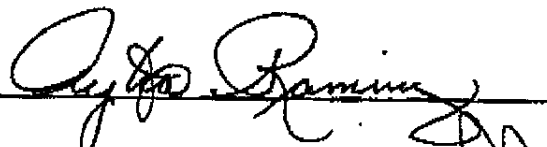
ARTICLE XI - BY-LAWS

The power to adopt, alter, amend or repeal By-laws shall be vested in the Board of Directors and the Shareholders.

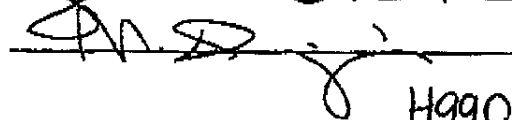

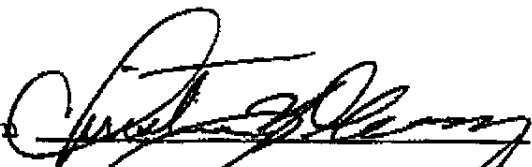
