The name of the corporation is Cuchy Tropical Coin Laundry Corp.

**ARTICLE II. DURATION AND COMMENCEMENT OF EXISTENCE**

The corporation is to have perpetual existence, commencing at the filing of these articles with the Department of State.

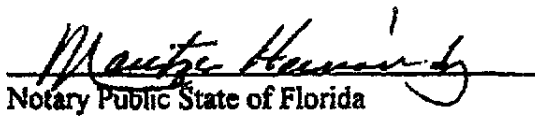

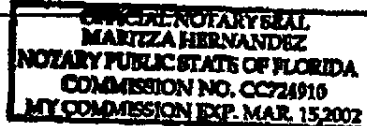
