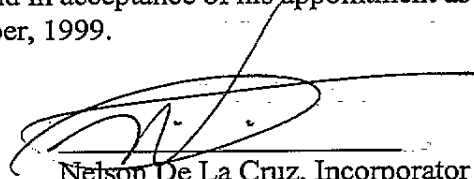
Article VII
