OF

(A Corporation for Profit)

The undersigned, desirous of forming a corporation, for profit, under the provisions of Ch. 607.0202(B) of the Florida Statutes, do agree to the following:

ARTICLE I. NAME

The name of the corporation is E-Z Rider Café, Inc.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

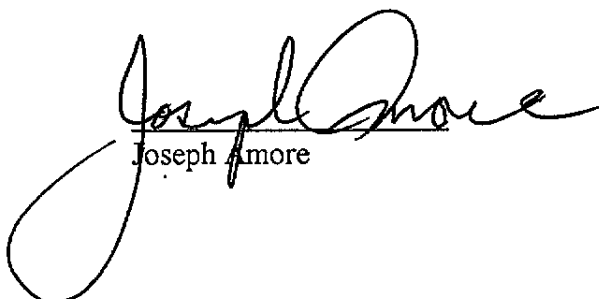
ARTICLE X. BY-LAWS

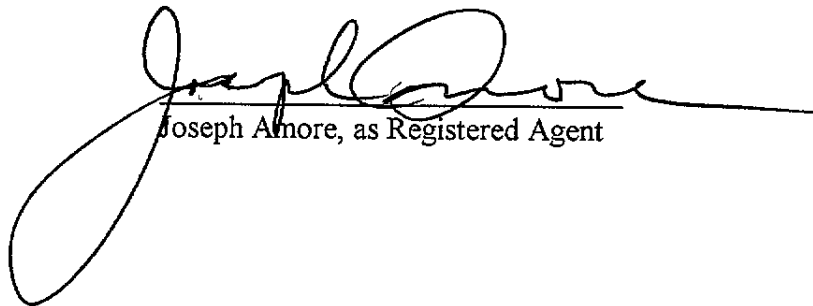
