ARTICLE I
NAME OF THE CORPORATION

The name of the corporation is Continental Building Services, Inc.

ARTICLE II

ARTICLE III



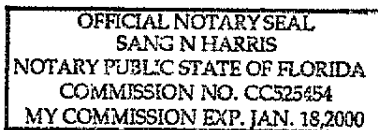
