ARTICLES OF INCORPORATION OF First Matt, Inc.

ARTICLE I - NAME, PRINCIPAL OFFICE AND MAILING ADDRESS

The name of this corporation is First Matt, Inc. and the principal office and mailing address of this corporation is 2503 W. Gardner Ct. Tampa, FL 33611.

ARTICLE II - PURPOSE
