## ARTICLES OF INCORPORATION ANAMARK INTERNATIONAL CORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

## ARTICLE 1. NAME. The name of the corporation is: ANAMARK INTERNATIONAL CORPORATION

- ARTICLE 2. DURATION. The duration of the corporation is perpetual.
- ARTICLE 3. PURPOSE. The general purposes for which the corporation is organized are the following:
- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. \_\_\_To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.
- ARTICLE 4. CAPITAL STOCK. The aggregate number of shares which the corporation is authorized to issue is 1000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.
