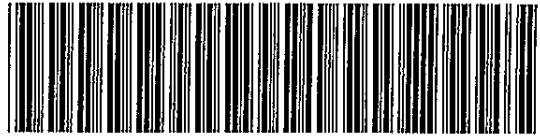




The undersigned, as the officer the corporation authorized to execute this document, hereby certifies as follows:

At a special joint meeting of the Board Of Directors and the shareholders of this corporation, called and held according to the applicable provisions of the laws of Florida and this corporation's bylaws, on March 7, 2002, at which meeting all of the members of the Board Of Directors and all of the stockholders of record holding a majority of the issued and outstanding stock in this corporation were present, and the following resolution was unanimously adopted:

It is hereby resolved, by the Board Of Directors and the shareholders of INTERTRADE FOREX INC., that the said Board Of Directors and shareholders deem it advisable, and hereby declare it to be advisable that the Articles Of Incorporation of INTERTRADE FOREX, INC. be amended to change the corporate name from INTERTRADE FOREX, INC. to PALM TREE INTERNATIONAL TRADING CORPORATION.

That pursuant to an agreement in March of 2002, the name InterTrade Forex, Inc. was going to be given up to a Delaware Corporation incorporated with that name. The business operations and dealings of the Delaware Corporation were completely separate from the Florida entity with the same name. The Florida entity agreed to change its name back to what it was prior to a name change on April 6, 2000 of Palm Tree International Trading Corporation.



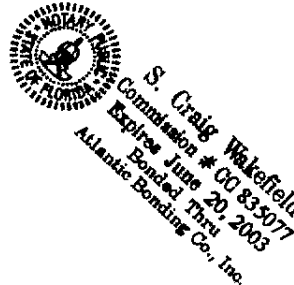
