ARTICLES OF INCORPORATION

OF

TAMPA BAY INJURY CENTERS, INC.

ARTICLE I

The name of this corporation is TAMPA BAY INJURY CENTING.

ARTICLE II DURATION

This corporation shall have perpetual existence commencing upon the filing of this Articles of Incorporation.

ARTICLE III PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under the laws of the State of Florida as now exist or may after be amended.

ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue 30,000 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."
