**ARTICLE I: NAME**

The name of this corporation is **CBM Electric, Inc.**

**ARTICLE II: DURATION**

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles of Incorporation.

**ARTICLE III: PURPOSE**

This corporation is organized for the purpose of engaging in any and all activities or business permitted under the laws of the State of Florida and the United States of America.

**ARTICLE IV: CAPITAL STOCK**

Initial Issue. One Thousand (1,000) shares of stock of the corporation shall be issued for cash or notes at a value of \$1.00 per share.

**ARTICLE V: PRINCIPAL OFFICE AND REGISTERED AGENT**

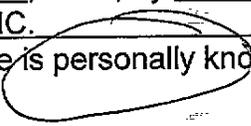

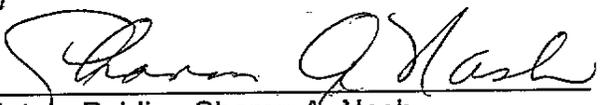

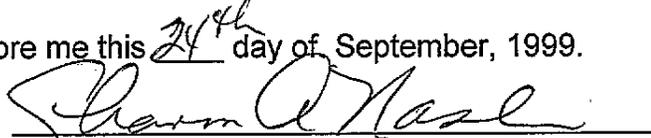
