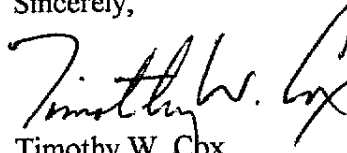

**ARTICLES OF INCORPORATION
OF
COX FUNDING CORPORATION**

ARTICLE I - NAME

The name of this corporation is Cox Funding Corporation.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing these articles.

ARTICLE III - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, in accordance with the provisions of the Florida Business Corporation Act.

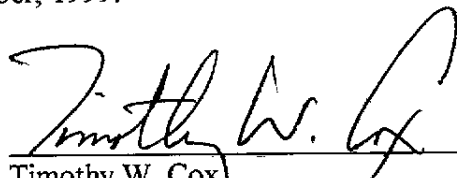
ARTICLE XII - AFFILIATED TRANSACTIONS

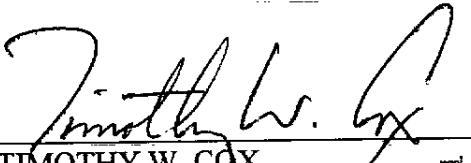

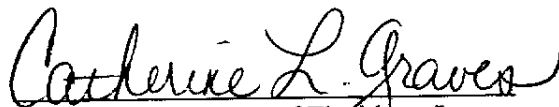
