**ARTICLES OF INCORPORATION
OF
EDG INVESTMENT COMPANY**

ARTICLE I - NAME

The name of the corporation shall be EDG Investment Company (hereinafter, the "*Corporation*" or the "*Company*").

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS
