### ARTICLES OF INCORPORATION

ARTICLE I

The name of the Corporation is Walls & Co. Management, The.
The address of the Corporation is 4237 Henderson Boulevard, Tampa, Florida, 33629.

#### ARTICLE II DURATION

The Corporation shall have perpetual existence.
