**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is REALCOW, INC., and the principal address and principal place of business is 4820 PARK BOULEVARD, PINELLAS PARK, FLORIDA 33781.

**ARTICLE II - REGISTERED OFFICE AND AGENT**
