#### ARTICLES OF INCORPORATION

OF

Ice Fit, Inc.
ARTICLE I

#### CORPORATION NAME

The name of this corporation is Ice Fit, Inc.

### ARTICLE II PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

### ARTICLE III CAPITAL STOCK

This corporation is authorized to issue 100 shares of common stock.

The common stock of the Corporation shall have the following characteristics:

- (a) Par value shall be \$1.00 per share
- (b) At all meetings of the stockholders, the common stockholders shall be entitled to cast (1) vote for each share of common stock owned. That a common stockholder is interested in a matter shall not disqualify him from voting thereon.
- (c) Except as otherwise provided by law, the entire voting power for the election of directors and all other purposes shall be vested exclusively in the holders of the outstanding stock.

## ARTICLE IV TERM OF EXISTENCE

This Corporation shall have perpetual existence.

#### ARTICLE V

The street address of the initial registered office of this Corporation is 3200 N. Military Trail #201, Boca Raton, FL 33431, the name of the initial registered agent of this Corporation is Louise M. Taylor. The Board of Directors may, from time to time, change the street address of the Corporation as well as the location of its principal office. This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.
