OF
STORE PLANNING & DESIGN, INC.

ARTICLE ONE

The name of this corporation is STORE PLANNING & DESIGN, INC. and the mailing address of the corporation shall be 1560 Matthew Drive, Suite C, Fort Myers, Florida 33907.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

The duration of the corporation is perpetual.

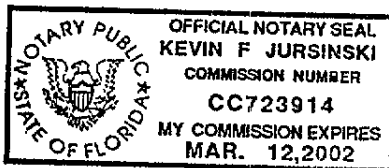
