ARTICLES OF INCORPORATION OF

Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of COLLEGE REAL ESTATE.COM, INC., are hereby amended according to these Articles of Amendment:

1. The name of this corporation is COLLEGE REAL ESTATE.COM, INC. (the "Corporation").
2. Article V of the Articles of Incorporation of the Corporation is hereby amended to read in its entirety as follows:

ARTICLE V
