OF

ARTICLE I

NAME

The name of the Corporation shall be:

ARTICLE II

PURPOSE

The purpose of the Corporation shall be all lawful purposes under the laws of the State of Florida.

ARTICLE III

AUTHORIZED STOCK

The maximum number of shares of stock of this Corporation which it is authorized to have outstanding at any one time is 500 shares of common stock at \$1.00 par value. Said stock shall be non-assessable and shall be payable in lawful money of the United States or in property, labor, or in



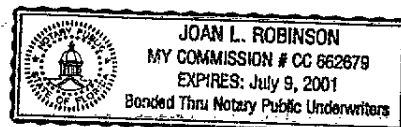


