ARTICLE I - NAME

The name of the corporation is LEECRIS ENTERPRISE EAST, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSES

This corporation is organized for the purposes of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of \$1.00 value common stock, which shall be designated "Common Shares."

ARTICLE V - VOTING RIGHTS
