**ARTICLE I - NAME**

The name of this Corporation is Adams Street Bakery and Cafe, Inc.

**ARTICLE II - DURATION**

The Corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

**ARTICLE IV - CAPITAL STOCK**

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1000 shares of common stock having a par value of \$1.00 per share.

**ARTICLE V - PRINCIPLE AND INITIAL REGISTERED OFFICE AND AGENT**

The principal and initial registered office of this Corporation shall be 208 South Adams Street, Tallahassee, Florida, 32301. The initial registered agent of this Corporation at such office shall be James A. Greer who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.

The initial board of Directors shall consist of 1 member(s). The number of directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the directors be less than one or more than 9. 




