Today, I received your enclosed letter (400A00054762) and the attached check. I made a quick call to your department and that person suggested a letter explaining my situation.

Linksland Golf is my first corporation and I was not aware of any state reporting requirements. The UBR arrived in my P.O. Box the first week of October 2000.
