ARTICLES OF INCORPORATION

OF

A-1, 24 HOUR BAIL BONDS, INC.

ARTICLE I - NAME

The name of the corporation is a-1, 24 hour bail bonds, inc., 1500 Tropic Park Drive, Suite 1510, Sanford, Florida 32773.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of the filing of these Articles of Incorporation by the Florida Department of State pursuant to the laws of Florida..

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business which corporations may conduct pursuant to the laws of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 7,500 Shares of common stock with \$1.00 par value, which shall be designated "Common Shares."

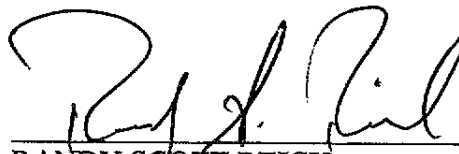
ARTICLE IX - POWERS

ARTICLE X - AMENDMENT

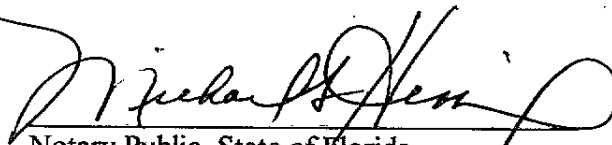

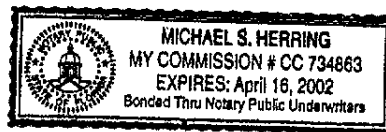
