ARTICLE I. NAME

The name of this corporation is TWO WORLDS, INC.



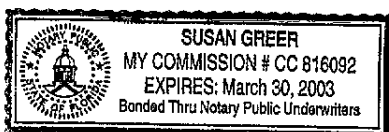
