**ARTICLE I - NAME**

The name of this corporation is **ASTRO CLEANING LIGHTS, INC.**

Principal address is 5875 W. Flagler St., Ste: 205, Miami, FL 33144.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States and of the State of Florida.

**ARTICLE IV - CAPITAL STOCK**

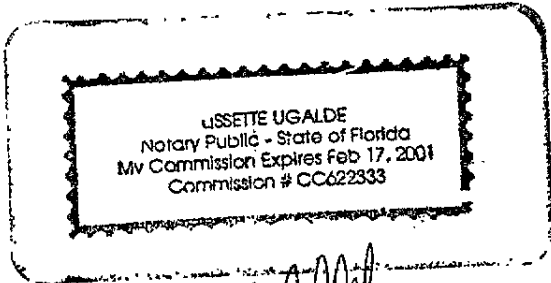

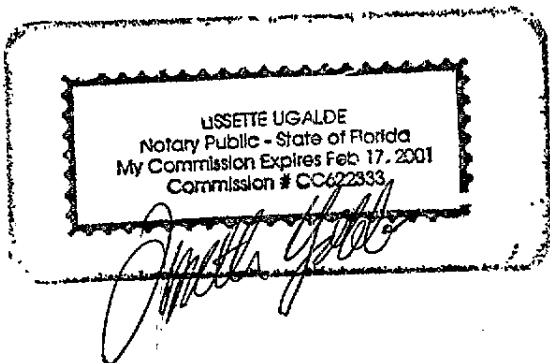
