(GENERAL)

ARTICLE I

GENERAL

The name of the Corporation is

FLORIDA POSTNET DEVELOPMENT CORPORATION, INC.

ARTICLE II

PURPOSE

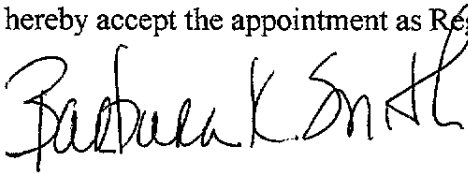
