ARTICLES OF INCORPORATION OF
EL CHAPARRAL CAFETERIA RESTAURANT CORP.

We, the undersigned hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation shall be EL CHAPARRAL CAFETERIA RESTAURANT CORP.

ARTICLE II

This corporation is to have perpetual existence.

ARTICLE III

The corporation may engage in any activity or business permitted under the laws of the United States and/or of the State of Florida.

ARTICLE IV

The maximum number of shares of stock with no par value that this corporation is authorized to have outstanding at any one time is one hundred (100) shares.

ARTICLE V

The amount of capital with which this corporation will begin business will be not less than five hundred (\$500.00) dollars.



WE THE UNDERSIGNED, being each and all of the original subscribers to the capital stock hereinabove named for the purpose of forming a corporation for profit to do business both within and without the State of Florida, do hereby make, subscribe, acknowledge and file this Articles of Incorporation, hereby declaring and certifying that the facts herein stated are true, and do respectively agree to take the number of shares of stock hereinabove set forth as to each of us, and accordingly have hereunto set our hands and seals this October 1, 1999.

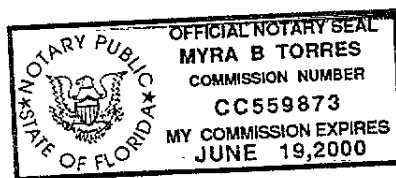
