Name and Location

1.1. The name of the corporation is **ECO- LOGIC CAREFUL TERMITE AND PEST SOLUTIONS, INC.** The mailing address of the corporation is 394 Tavernier Circle, Oldsmar, Florida 34677.

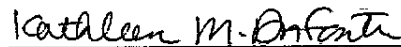
