Please reinstate the above-mentioned corporations. Per our phone conversation yesterday, I am sending the 2001 Uniform Business Reports (UBR) and checks in the amount of \$150, for A.J. Lang Financial Services, Inc., and Lorri R. Miller, CPA, PA. Thinking the original Form UBR had been timely filed and received by May 1, 2001, I disregarded the 60-day notice sent by the State during the Summer when I was in the process of moving my office.

As I suggested, there may have been a breakdown in delivery service at that time because there has been other things mailed in April which have not reached their destination. For example, I am the President of my condominium association and one of my neighbors sold his condo, closing on April 12, 2001. I had completed the estoppel and sent the original via U. S. Postal Service prior to the closing, but it never reached the title company.
