ARTICLES OF INCORPORATION

of



FANCY FLOWERS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - Name and Address

The Name of this corporation is FANCY FLOWERS, INC. (hereafter referred to_as the Corporation). The Corporation's principal address is:
