ARTICLES OF INCORPORATION

We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the State of Florida, adopt the following Articles of Incorporation:

- FIRST** The name of the corporation is: TDM BILLBO'S, INC.
- SECOND** The period of its duration is: Perpetual.
- THIRD** The purpose of the corporation is: To engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.
- FOURTH** The aggregate number of authorized shares is: 10,000 shares of common stock having no par value.
- FIFTH** The corporation will not commence business until at least \$100.00 dollars have been received by it as consideration for the issuance of shares.
- SIXTH** Cumulative voting of shares of stock is authorized.
- SEVENTH** Provisions limiting or denying to shareholders the pre-emptive right to acquire additional or treasury shares of the corporation are: Every shareholder, upon the sale for cash of any new stock of this corporation

of the same class or series as that which is already issued, shall have the right to purchase a prorata share thereof at the price at which it is offered to others.

EIGHTH Provisions for regulating the internal affairs of the corporation are: Vested in the Board of Directors, subject to any limitation set forth in these Articles of Incorporation or the By-Laws of the Corporation.

NINTH The address of the initial registered office of the corporation is: 3501-302 Del Prado Boulevard; Cape Coral, Florida 33904 and the name of its initial registered agent at such address is: Paul L. Larrow.

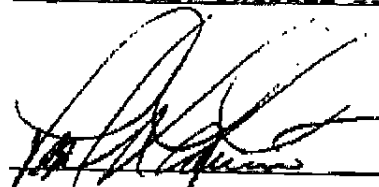

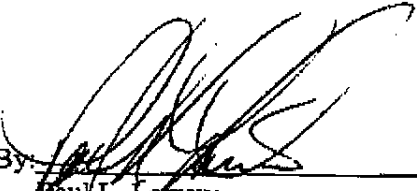
