We are the new accountants for Express Tan Inc., and in receipt of your final 2002 Uniform Business Report. We are requesting that the \$400 penalty be waived due to the following extenuating circumstances.

This corporation changed hands on the first of the year. Brandi Botts, the new President/Shareholder remodeled the store prior to reopening the business under her management on January 27, 2002.
