



This letter is being sent as a courtesy reminder that the 2001 Uniform Business Report ("UBR") for the above-named corporation must be filed by May 1st with the Florida Department of State. A check of the Florida Corporations On-Line web site shows that the UBR had not been filed as of April 23<sup>rd</sup>.

Section 607.1622(1) of the Florida Statutes states that "Each domestic corporation... shall deliver to the Department of State for filing a sworn annual report on such forms as the Department of State prescribes..." Furthermore, Section 607.1622(8) provides that "Any corporation failing to file an annual report which complies with the requirements of this section shall not be permitted to maintain or defend any action in any court of this state until such report is filed and all fees and taxes due under this act are paid and shall be subject to dissolution or cancellation of its certificate of authority to do business as provided in this act."

Please note that George Golder left our firm a while ago to work as in-house corporate counsel for another organization. Because of this, you will most likely want to change the Registered Agent to yourself. The new Registered Agent will sign the UBR on line 8. Our firm is still available to handle your legal needs and welcomes any questions or comments you may have regarding this matter.

You may be able to file the UBR electronically by following the instructions for Electronic Filing on the next page. If you are unable to do so, then make sure your original UBR has been postmarked by May 1<sup>st</sup>. The filing fee is \$150 prior to May 1<sup>st</sup>, and thereafter increases to \$550.
