Dear Mrs. Ashton:

Recently I received the enclosed notice, informing me that I had not filed the 2000 Uniform Business Report. The notice enclosed is the first notification that I received that I am required to file a Uniform Business Report. The notice stated that I must fill in all applicable information and remit the form with a check for \$550.00. I started my corporation in late 1999 and have never been exposed to these documents before.

I called the Division of Corporations and was informed that the \$400.00 late fee was imposed because I failed to file the form by May 1, 2000. Because the first notice I received was in early September, I could not possibly return the form prior to May 1, 2000. On September 5, 2000 I wrote a letter to the Division of Corporations explaining my situation. That letter was returned to me along with my check. Today, I called the Division of Corporations again and was told to write another letter and address it to you personally.
