Name of Corporation

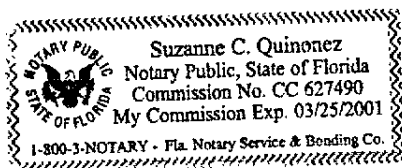
