### ARTICLES OF INCORPORATION OF

SECRETARE

#### Princess Diamonds Corporation

FIRST: The name of the Corporation is **Princess Diamonds Corporation** (the "Corporation").

SECOND: The duration of the Corporation is perpetual.

THIRD: The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be formed under Chapter 607 of the Florida Statutes.

FOURTH: The Corporation is authorized to issue 10,000 shares of common stock, \$.001 par value and 5,000 shares of preferred stock, \$.01 par value.

The preferred stock may be issued from time to time in series, with such designations, preferences, conversion rights, cumulative, relative, participating, optional or other rights, qualifications, limitations or restrictions thereof as shall be stated and expressed in the resolution or resolutions providing for the issuance of such preferred stock, adopted by the Board of Directors pursuant to the authority granted in these Articles.

FIFTH: The street address of the initial registered office of the Corporation is: 7500 West Commercial Boulevard, #1-A Lauderhill, Florida 33319 and the name of the registered agent of the Corporation is: Moshe Ben Lulu.

SIXTH: The Corporation shall have one director initially and the number of directors may be increased or diminished from time to time as provided in the By-Lays but shall never be less than one. The name and address of the initial director of the Corporation is: Moshe Ben Lulu, 10080 Reflections Boulevard, #206, Sunrise, Florida 33351-8309.

SEVENTH: The name and address of the incorporator of the Corporation is: Moshe Ben Lulu Sunrise, 10080 Reflections Boulevard, #206, Sunrise, Florida 33351-8309.

EIGHTH:

The Corporation shall indemnify, or advance expenses to, to the fullest extent authorized or permitted by the Florida General Corporation Act, any person made or threatened to be made, a party to any action, suit or proceeding by reason of the fact that he (i) is or was a director of the Corporation; (ii) is or was serving at the request of the Corporation as a director of another corporation; (iii) is or was an officer of the Corporation, provided that he is or was at the time a director of the Corporation; or (iv) is or was serving at the request of the Corporation as an officer of another corporation, provided that he is or was at the time a director of the Corporation or a director of such serving at the request ο£ corporation, Corporation. Unless otherwise expressly prohibited by the Florida General Corporation Act, and except as otherwise provided in the foregoing sentence, the Board of Directors of the Corporation shall have the sole and exclusive discretion, on such terms and conditions as it shall determine, to indemnify, or advance expenses to any person made, or threatened to be made, a party to any action, suit, or proceeding by reason of the fact that he is or was an officer, employee or agent of the Corporation or is or was serving at the request of the Corporation as an officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise. No person falling within the purview of the foregoing sentence may apply for indemnification or advancement of expenses to any court of competent jurisdiction.

NINTH:

The Corporation expressly elects not to be governed by Section 607.108 of the Florida General Corporation Act as amended from time to time, relating to affiliated transactions.

TENTH:

The Corporation expressly elects not to be governed by Section 607.109 of the Florida General Corporation Act as amended from time to time, relating to control share acquisitions.

ELEVENTH: The corporate existence of the Corporation shall commence September 21, 1999.
