ARTICLE I. NAME

The name of this corporation is ABC MORTGAGE LENDING, CORP.

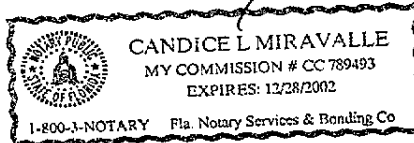
