**ARTICLE I**

**CORPORATE NAME**

The name of this Corporation is ED PAWLOWSKI TRUCKING, INC. The principal office and mailing address of the corporation is 4340 Second Avenue SE, Naples, Florida 34117.

**ARTICLE II**

**DURATION**

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

**ARTICLE III**

**PURPOSE**

The Corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV**

**CAPITAL STOCK**


