THE UNDERSIGNED, for the purpose of forming a corporation under the Florida Corporation Act, does hereby adopt the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of the Corporation is **PAPERTRAX, INC.**, and the principal place of business is 108 Jay Drive, Altamonte Springs, Florida 32714.

**ARTICLE II
DURATION**

The duration of the Corporation is perpetual.

**ARTICLE III
PURPOSE**

The general purpose for which the corporation is organized are:

1. To carry on the business of printing documents, preparing documents, for businesses, and corporations, both commercial or non commercial, developing potentials, opportunities, resources, businesses, industries and their needs, and to provide facilities for exchange of products, services, ideas for the communities and in all ways to enhance the value of this corporation
2. To transact any other lawful business for which corporation may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, at

the option of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

3. To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes, the attainment of any of the objects or the exercise of any of the powers herein set forth, either alone or in conjunction with other corporations, firms or individuals, and either as principals or agents, and to do every other act or acts, thing or things incidental or appurtenant to or growing of or connected with the above mentioned purpose or powers.

ARTICLE IV CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue in Ten Thousand Shares (10,000) Common A Stock. The par value is 0.01 per share.

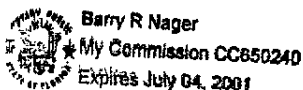
