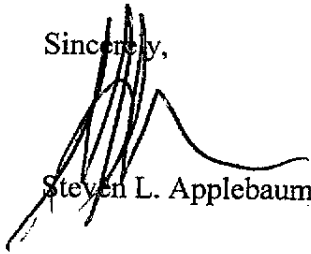

of

Article I. Corporate Name and Initial Corporate Address

The name of this corporation is **Smith-Hall Systems, Inc.**, and the initial corporate address is 3379 SW 49th Street, Hollywood, Florida 33312.

Article II. Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

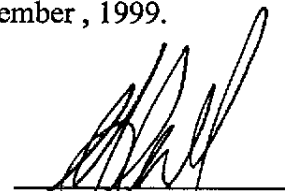

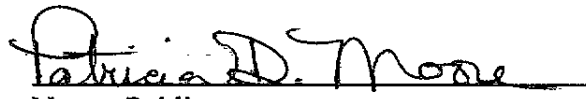
