TO THE ARTICLES OF INCORPORATION OF

I, Lloyd D. Brownhill, President of Space Coast Teleport, Inc., a Florida corporation, hereby certify to the Secretary of State, State of Florida, that on the 21st day of OCTOBER, 1999, the following resolution was approved by a greater than majority of the stockholders entitled to vote, said number of votes cast being sufficient for approval of the Amendment, by Written Consent In Lieu of Meeting, pursuant to the provisions of Florida Statutes, Section 607.0704, and direct that this Consent be incorporated into the Minute Book of the Corporation:

RESOLVED, that pursuant to the provisions of the Articles of Incorporation of Space Coast Teleport, Inc., the said Articles of Incorporation are hereby amended by altering Article I in its entirety, so as to read as follows:
