ARTICLES OF INCORPORATION
OF

We, the undersigned incorporators, do hereby form a corporation for profit under the general laws of the State of Florida pursuant to Section 607.0202, Florida Statutes, and do hereby certify as follows:

ARTICLE I

The name of the corporation shall be Steve R. Daniels, Inc.

ARTICLE II

The location of the principal place of business shall be 870 -64th Street, Ocean, Marathon, Florida 33050.

ARTICLE III

The corporation shall have perpetual existence.

ARTICLE IV

The Registered office of this corporation is 870 64th Street, Ocean, Marathon Florida 33050 and the name of the initial registered agent of the corporation at that address is Steve R. Daniels.

ARTICLE V

The general nature of the business to be transacted shall be the following:

1. The amount of capital before beginning business shall be at least Five hundred and No/100 Dollars (\$500.00).




