**ARTICLE I**





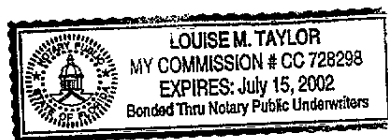
