**ARTICLES OF INCORPORATION
OF
GLOBAL RESOURCE RECOVERY ORGANIZATION, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is **GLOBAL RESOURCE RECOVERY ORGANIZATION, INC.**, the ("Corporation").

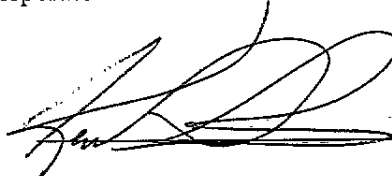

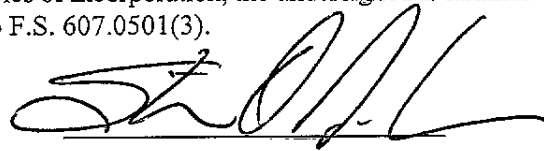
