DEC. 10, 1999


By and between BATTLE MOUNTAIN CORPORATION, a Florida corporation, the acquiring corporation, and ANGLO AMERICAN CONSOLIDATED CORPORATION, a Colorado corporation, the acquired corporation that shall cease to exist, now hereafter:

1. ANGLO AMERICAN CONSOLIDATED CORPORATION, a Colorado corporation, was authorized on August 9, 1983 as BATTLE MOUNTAIN CORPORATION, a Colorado corporation, which changed its name in accordance with the laws and statutes of the State of Colorado on December 29, 1994 to ANGLO AMERICAN CONSOLIDATED CORPORATION. The Colorado corporate identification number is 871533459.
2. BATTLE MOUNTAIN CORPORATION, a Florida corporation, was authorized on October 4, 1999. The Florida corporate identification number is P99000088324.
3. ANGLO AMERICAN CONSOLIDATED CORPORATION by its shareholders and directors shall enter into a voluntary plan of merger with BATTLE MOUNTAIN CORPORATION, the acquiring corporation.
4. BATTLE MOUNTAIN CORPORATION shall acquire all 1000 shares of ANGLO AMERICAN CONSOLIDATED CORPORATION by exchanging \$1.00 for each share.
5. 100% of the shareholders and directors of each corporation have voted to approve the plan of merger.
