

ARTICLE ONE

The name of the corporation is **SUNSHINE STATE FASHION EXHIBITORS, INC.** The principal address of the corporation is: 485 Spinnaker Rd., Weston, FL 33326

ARTICLE EIGHT


The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
